Please submit your abstract in MS Word format (.doc) or Rich Text Format (.rtf) and limit the length of the abstract to one page of text and one page of graphics. The abstract should be sized for 8.5" x 11" paper. There should be a 1" (25 mm) margin on all sides (top, bottom and both sides). Use Times New Roman Font and the following formatting:

1. The title should be centred and in 14pt Bold Capitals.
2. There should be one 14pt line space after the title.
3. The name and affiliation of the author designated to receive correspondence should be centred in 10pt font below the title. The corresponding authors affiliation should include:
 - a. Name of the author designated to receive correspondence
 - b. Complete mailing address of the corresponding author
 - c. Telephone number of the corresponding author
 - d. FAX number of the corresponding author, if available
 - e. E-mail address of the corresponding author
 - f. Name of Topic Area and preferred mode of presentation (oral or poster)
 - g. The list of co-authors and their affiliations (including mailing address)
4. The text in 11pt font should be fully justified, single -spaced, and in single column format.

New paragraphs should have an indent of 0.5" (12 mm).

5. Figures must appear within the designated margins on a page. Every figure must have a numbered caption in 11pt below the figure.
6. The abstract will be evaluated on the basis of the clarity of objective, scope and method of approach, and significance of the results. The author designated as the author for correspondence will be notified of the paper's acceptance or rejection.
